Early in 2020, the Kerr Village BIA was getting ready for the upcoming year. Planning was in the early stages for Kerrfest and the planting of a Christmas Tree in Westwood Park. Little did we know at the time that once March arrived, things would change dramatically due to Covid-19 for our business district and the community. During 2020, the BIA Budget tax levy was reduced by 38%, sanitizer and social distancing decals were made available to the merchants.

Advocacy on issues took place through best practices on how small business could work with their local MP, MPP, Region, and Municipality. The information that we did receive was sent out to our merchants. The Kerr Village BIA was a member of the Mayors Economic Recovery Task Force and the Economic Recovery & Resiliency Group. Initiatives were provided through Welcome Back Oakville and Digital Main Street. Patio program fees were waived, and the season was extended through the end of December. We still maintained our street scaping and beautification, while also having a virtual Tree Lighting Ceremony.

We need to continue our efforts as we move forward through the economic recovery phase.
